Many people are reaching out to the ICP Care team for information right now resulting in longer than normal wait times. To provide you with more immediate help please see the below answers to our frequently asked questions. Thank you for your patience and understanding.

### What ICP disinfectants can be used against COVID-19?

The products listed here are eligible to be used against the COVID-19 on hard, non-porous surfaces. Per the EPA's Emerging Pathogen Policy, these products can be used against COVID-19 when used in accordance with the directions for use against the virus listed for each product on hard, non-porous surfaces.

# I can't find ICP Disinfectants anywhere. Why is that?:

Production of our disinfecting products have been increased to meet the demand of our customers. This is a very dynamic situation, and ICP's supply team is working around the clock to address these demand needs, and ensure that our customers have access to our disinfecting products.

### When can I expect to see your products back in stores?

Production of our disinfecting products have been increased to meet the demand of our customers. It's difficult to determine when our customers will have product back in stock. This will vary by customer, location

and region. We are working hard to keep up with production of disinfectants and are communicating closely with our distributors to ensure they have a supply of disinfectants for their customer base.

## How are you prioritizing where to restock? Have you started allocations for retailers?

We are working closely with our distribution partners to provide disinfectant products. Product sizes and types may vary during this time, which allows our manufacturing locations the ability to maximize production capabilities. With that in mind, we are working with all of our partners on the best solutions to keep them supplied with disinfectants.

#### Are you manufacturing all disinfectants? How are you prioritizing what you produce?
